# **Purpose**

The purpose of this report is to present the monthly financial report for Thorak Regional Cemetery for the period ended 31 January 2017.

# Recommendation

THAT Council receive the Thorak Regional Cemetery finance report for the period ended 31 January 2017.

# **Background**

During January 2017 a detailed review of all activity areas of the Thorak Regional Cemetery to provide an accurate forecast to 30 June 2017 and to inform 2017/18 budget deliberations.

Forecasts for Thorak Regional Cemetery are summarised in the table below.

Item	Summary	Indicator
Operating Income	There is an unfavourable variance of \$76,767 in operating income forecast at 30 June 2017.	
Operating Expenditure	There is a favourable variance of \$47,189 in operating expenditure forecast at 30 June 2017	•

To conclude, Thorak Regional Cemetery's overall forecast result is unfavourable to Budget by \$29,578. However, this is better than previously forecast due to significant savings made in the operating expenditure.

# **OPERATING RESULT**

Below is a summary of the operating results to the end of January 2017.

The Cemetery had 21 internments and cremations (6 burials and 15 cremations) compared to 18 (10 burials and 8 cremations) during January last year. Year to date total at the end of January is 149 interment and cremations (54 burials and 95 cremations), down 2 compared to the same period last year (84 burials and 67 cremations).

The end of financial year revenue is forecast to decrease by \$76,767 against Budget because of the reduction in burials of 36%, confirming the national trend that cremations are preferable opposed to burials.

End of financial year expenditure levels are forecast to decrease by \$47,189.

Revenue and expenditure levels will continue to be monitored closely throughout the financial year.

# **CAPITAL RESULTS**

The 2016/17 net capital expenditure relates to the trade-in and purchase of a new motor vehicle, in accordance with Council's Motor Vehicle policy. The disposal will occur at the next fleet auction with a reserve of \$10,500.

Thorak Cemetery's Case Tractor was disposed of on 14 December 2016, the proceeds from Pickles Auctions will be \$26,827, after fees and charges.
