# **COUNCIL REPORT**

### **Purpose**

The purpose of this report is to present the monthly financial report for Thorak Regional Cemetery for the period ended 31 March 2017.

### Recommendation

THAT Council receive the Thorak Regional Cemetery finance report for the period ended 31 March 2017.

### **Operating Result**

For the month of March 2017, the Cemetery had 20 internments and cremations (9 burials and 11 cremations) compared to 21 (9 burials and 12 cremations) during March last year. Year to date total at the end of March is 193 interments and cremations (74 burials and 119 cremations), up one compared to the same period last year, however the breakdown varied this year at 104 burials and 88 cremations. End of financial year revenue is forecast to decrease by \$63,281 due to the 29% reduction in burials, which follows the national trend that cremations are preferred to burials. End of financial year expenditure levels are forecast to decrease by \$33,703. Revenue and expenditure levels will continue to be monitored closely throughout the financial year.

The 2016/17 net capital expenditure relates to the trade-in and purchase of a new motor vehicle, in accordance with Council's Motor Vehicle policy. Thorak Cemetery's Case Tractor was also sold via Pickles Auctions for \$26,827 after fees and charges.
