#### **Executive Summary**

Following receipt of a request from a member of public in regard to the naming of the shared path network that extends from the Daly Street Bridge in Darwin city to Coolalinga, this report proposes in principle support be provided to the applicant in order to progress the matter with Place Names NT.

#### Recommendation

THAT Council:

- 1. receive and note the request as detailed in Attachment A;
- 2. provide in-principle support for the naming of the shared path network (or part thereof) as outlined in Attachment A to be 'North Australia Railway Trail' or as deemed appropriate subject to further historical information and provide a letter to Place Names NT; and
- 3. provide delegation to the CEO to approve further documentation in relation to the naming of the shared path network as deemed necessary.

#### Background

Council received a request from Mr Gerry Wood in March 2024 following direction from Place Names NT in relation to the naming of the shared path network that extends from Darwin City to Coolalinga.

As per the guidelines of Place Names NT the applicant is to contact and receive support from all the necessary stakeholders in relation to the naming of a road, site, infrastructure and various other types of formations. Council's policy INF04 Place Names aligns with these guidelines and as such Council has developed an information sheet to provide to applicants to assist with the process.

In brief review, the proposal to name the section of shared path from the Daly Street Bridge (Darwin City) to Coolalinga would align with the principles of Place Names NT commemorating historical places.

Further information would need to be sort in regard to the exact location of the historical railway in relation to the current shared pathway. Also, whether the naming is North Australia Railway or North Australian Railway.

It should be noted, that the Shared Path Review is an existing project of the Department of Infrastructure, Planning and Logistics (DIPL) with a published paper with a summary of outcomes and proposed timeframes for recommendations and outputs. Currently there are no works referred to in relation to the naming of the shared path network segments however it would be expected that Place Names NT would refer the request to DIPL.

In this instance, it is recommended that Council provide in-principle support of the name and the context of the request in consideration of the historical significance.

As mentioned in the letter of request, this naming convention aligns with the naming style in other parts of Australia where extinguished rail corridors have been used for biking and walking trails. In principle support allows for Place Names NT to undertake their due diligence in the matter before providing their own recommendations to the Minister for Infrastructure Planning and Logistics.

#### INFORMATION

#### LITCHFIELD COUNCIL PLACE NAMES

#### Process to be completed

Under the NT Place Naming Process for obtaining Registered Names (such as Road Names), an applicant is required to consult the Local Government Authority and other interested parties prior to making a submission.

For all place names proceedings that occur within the Litchfield Municipality, Litchfield Council is the Local Government Authority and as such must be consulted.

Receiving a 'letter of recommendation' from Council is a necessary step in the process as it is a requirement that the letter be attached to any Place Names proposals submitted to NT Place Names Committee.

To obtain the letter of recommendation, Developers must forward a written application to Council containing the following information:

- Details of any naming theme proposed for an area.
- List of names proposed and a brief history of the origin of the name(s).
- □ A diagram of the location of the features to be named.
- □ Where streets are to be named, the developer is encouraged to provide additional names as secondary options to allow for names that may be rejected by the NT Place Name Committee.
- A Place Name search from the NT Place Names Register to demonstrate that names are not being duplicated in Litchfield Council, adjoining local government areas, or adjoining localities not within a local government area

The template overleaf can be used to complete the submission.

Once the above is completed, please submit applications to **council@litchfield.nt.gov.au** with the subject line: *PLACE NAMES APPLICATION\_<details of location or development>* 

The Planning and Development department will review the submission and, if any changes or further information is required, an officer will be in contact within 10 days.


Once the submission is approved for recommendation to Council, it will be placed on the agenda of a Council Meeting for Councillor endorsement. The applicant will be advised of the scheduled meeting date beforehand. Following the meeting, a letter will be returned noting the recommendation from Council. The applicant may then submit this to the NT Place Names Committee as part of the engagement process.

Please allow a minimum of 8 weeks for the process above to take place as per council policy INF04 Place Names.

# INTRODUCTION

The Department of Infrastructure, Planning and Logistics (DIPL) has undertaken a review of Northern Territory Government (NTG) owned shared paths across Greater Darwin, Katherine, Tennant Creek and Alice Springs.

Shared paths are important community assets and allow pedestrians, cyclists and mobility device users to move safely and efficiently around our cities and towns.

There is a growing demand for high quality shared path infrastructure across the Territory, with residents wanting a higher level of connectivity between work, home and other key destinations.

The recommendations of the review, which are outlined in this document, identify and prioritise path improvements that meet the needs of cyclists, mobility device users and pedestrians now and into the future. This document will serve as a guide over the next 10 years to ensure community needs are at the forefront of decision making.

#### SCOPE

The purpose of the NT Shared Path Review 2023-2033 was to assess the existing NTG owned shared path networks and provide recommendations for:

- » improvements to existing shared paths
- enhanced connectivity and network extensions between the existing network including between NTG roads and local government roads
- » long term planning, monitoring and review.

#### This was guided by the following key considerations:

- » routes that efficiently, effectively and safely service and connect to the current path network
- » provision of connections to key attractions including sporting, recreational and shopping facilities and tourist attractions
- » develop a clear and concise network of routes to encourage cyclists and pedestrians by providing safer and more convenient routes
- » define gaps in service and plans for future growth corridors
- » enhance connections to the existing and planned future local government networks
- » encouraging a more active population through the increase in attractive active transport options.

#### A range of existing literature was reviewed to ensure the recommendations of this review are aligned or complementary to existing strategies and plans. This included:

- » Greater Darwin Regional Land Use Plan Towards 2030
- » City of Darwin City Centre Master Plan
- » Darwin Regional Transport Plan 2018
- » Municipal plans
- » Towards Zero Action Plan 2018 2022.

In the Territory's towns and urban areas, responsibility for maintaining and upgrading shared paths is divided between NTG and local government. The review covered some connections to shared paths on local government roads with identified improvements limited to NTG shared paths.

### REVIEW PROCESS AND CONSULTATION

The review broadly included five key steps:

#### PRELIMINARY REVIEW

>3

- » Review background documents including design guidelines, existing plans, bicycle surveys, cyclist counts and crash data
- » Site inspections to understand network gaps, path connectivity, safety issues, identify required repair work and overall path condition

#### STAGE ONE CONSULTATION

- » Consulting with stakeholders and the community in all four locations to seek feedback and ideas
- » This included meetings, hardcopy and online surveys, interactive maps and workshops

#### ENGINEERING AND TECHNICAL ASSESSMENTS

» Identify a priority order of improvements based on stakeholder and community feedback and a multi criteria analysis

#### STAGE TWO CONSULTATION

- Re-engage with stakeholders and the community to present a list of infrastructure gaps and proposed improvements
- » Seek feedback on whether the proposals align with expectations and needs

#### FINALISE REVIEW

- » Develop a prioritised list of recommendations for each location based on consultation and a multi criteria assessment
- » Release an outcomes summary detailing each recommendation

### Stakeholder and community consultation was a crucial part of the review.

The feedback from Territorians ensures the outcome of the review meets the community's needs. Consultation was conducted with a broad range of organisations, groups and community members including:



Government departments



Local governments



Interested private sector organisations



Bicycle and running organisations and groups





Special interest groups



Stage one consultation involved raising awareness of the project through the provision of information and summarising how people could provide their thoughts and suggestions.

Following stage one consultation, all of the information gathered to date helped inform a draft proposal which was used as the basis for stage two. Stage two focussed on re-engaging with stakeholders and the community to collect feedback on the linkages and network expansions presented in the draft proposal. It sought to confirm whether the proposal aligned with stakeholder and community aspirations.

Community members who completed a survey ranked safety, connectivity and infrastructure quality as the most important components of a shared path. In Greater Darwin, the most popular improvement was a connection along the Stuart Highway from Coolalinga to Arnhem Highway. This was closely followed by a connection to Garramilla Boulevard from the Stuart Highway. In Alice Springs, the community voted in favour of a new path along Ross Highway between Ragonesi Road and the Emily and Jessie Gaps road access, along with a path extension north of the Motor Vehicle Registry to connect to the mountain bike trails.

Across all four locations, 36 meetings were held and more than 800 surveys and map responses were received. Various consultation methods were used during both stages to ensure a range of opportunities for people to be involved in the process. The methods included:



Face to face meetings



Phone calls



Hard copy surveys



Interactive maps



Virtual meetings



Emails



Online surveys





#### **ASSESSMENT OF PRIORITIES**

A multi criteria assessment was developed to rank each recommendation against criteria considered to provide value to the community. Each of the recommendations were given a score of high (3), medium (2) or low (1) for the following:



Safety



Bus stop connections



Network importance



Community support



Identified on existing plans or programs



Potential cost



Improved connectivity



Links to existing education, health, tourism or commercial land uses





### PROPOSED NETWORK

The review identified 118 improvements and upgrades. Improvements are grouped into short term, medium term and long term based on the multi criteria assessment. This will help ensure money is spent where it matters most for Territorians by considering the community's views and aspirations in decision making.

Delivery timeframes serve as a guide whilst still allowing for delivery efficiency and alignment with other DIPL priorities and projects. Priorities may change if a project forms part of a larger infrastructure upgrade.



#### **FUNDING OPPORTUNITIES**

The Northern Territory Government is committed to improving the safe and efficient movement of pedestrians, cyclists and mobility device users in the Territory. Over the past five financial years, DIPL has spent an average of \$2.4 million each year on shared paths – this includes upgrading existing paths and creating new links.

The NT Shared Path Review will allow DIPL to direct its yearly funding to the places that create a safer and better connected network aligned with community aspirations.



#### MONITORING AND FURTHER REVIEW

DIPL reviews the shared path network to facilitate ongoing development and maintenance. Previous reviews for Greater Darwin were undertaken in 1995, 1999, 2004, 2010 and 2015. Katherine was reviewed in 2001 and Alice Springs in 2009.

DIPL will conduct another formal review in 10 years. At the five year mark, DIPL will assess the current strategies to monitor the priority list of improvements to understand:

- » Are the objectives of the review being achieved throughout the delivery phase?
- » Have circumstances changed that may influence updates to the scope or timing of recommended improvements?
