#### **Executive Summary**

This report provides Council the correspondence received from the Local Government Association of the Northern Territory (LGANT) inviting nomination to the LGANT Executive Board.

#### Recommendation

THAT Council nominates Mayor Doug Barden to the Local Government Association of the Northern Territory Executive Board for the position of Board Director - Municipal.

#### **Background**

LGANT advised the Chief Executive Officer on 18 November 2024 of the following;

At the LGANT Annual General Meeting held on the 7 November we held our Board Election where the following appointments took place:

- President Lord Mayor Kon Vatskalis, City of Darwin (re-elected)
- Vice President Municipal: Councillor Allison Bitar, Alice Springs Town Council
- Vice President Regional and Shire: Mayor Brian Pedwell, Victoria Daly Regional Council
- Board Director Regional and Shire: Mayor James Woods, West Arnhem Regional Council (re-elected)
- Board Director Regional and Shire: Mayor Lynette De Santis, Tiwi Islands Regional Council
- Board Director Regional and Shire: Councillor Peter Clee, Wagait Shire Council (reelected)
- Board Director Municipal: Mayor Elisabeth Clark, Katherine Town Council (re-elected)
- Board Director Municipal: Casual vacancy
- Board Director Municipal (City of Darwin nominated position): Councillor Peter Pangquee, City of Darwin (re-nominated)

Due to the number of nominees received to the position of Board Director – Municipal we were left with one position remaining as a casual vacancy.

Section 19(c) of the <u>LGANT Constitution</u> states that: "If a casual vacancy occurs on the Board for a position other than the President or a Vice President, the Chief Executive Offier shall advise Member Councils and invite nominations to be forwarded for consideration at the next Board Meeting"

**Subsequently,** Section 17(g) of the <u>LGANT Constitution</u> states that: "Only one elected member from each Member Council can be elected as a Director of the Board..."

As all other Member Municipal Councils have representation on the Board we are able to call on Litchfield Council to directly nominate for the vacant position.

Please find attached the nomination form and information noting, that while this is a direct call for nomination from Litchfield Council we are bound by our Constitution and must follow the same nomination process – details are within the attached documents with main requirements to note being:

- The nomination must be endorsed by way of resolution at a Council meeting
- Nominee must complete the attached nomination form in full
- Nominee must hold a Directors ID

Upon receipt, LGANT will assess the nomination and if complete will seek endorsement by the Board.
