9. PUBLIC FORUM

Public comments are paraphrased in the minutes and not recorded verbatim

9.1 Ross Lavender – Big 4 Caravan Park Howard Springs

Mr Lavender objected to supporting a free RV Park however was not objecting to a dump point as seen it as an advantage to travellers. Mr Lavender stated that commercial operators are required to dump rubbish at Shoal Bay at a cost and questioned the process with a free RV Park. Mr Lavender believed the RV Park was going to be in direct competition to surrounding businesses.

9.2 Peter Close – McMinns Lagoon

As a member of the CMCA and former manager of caravan parks Mr Close supported the motion as he believed more vehicles are self-contained therefore travellers needs have changed. Mr Close believed that if a dump point and RV Park was available it would attract more travellers / grey nomads.

9.3 Troy Wright – Humpty Doo

Mr Wright as a local business man raised his concerns in relation to the financial impact to surrounding caravan parks also to small businesses that provide a service to the caravan parks.

9.4 Ray McCaster - Virginia

As a caravan park owner Mr McCaster believed that majority of rate payers would not benefit from a free RV Park and believed the money would be better spent at Freds Pass Reserve, roads and drainage.

9.5 Christine Boothby – Nakara

As a long-term Darwin resident and a member of the CMCA Mr Boothby believed the proposal would improve the economic development of the area. Mrs Boothby also believed the RV Park and dump point would be at no cost to the ratepayers.

9.6 Kay Pisani – Wulagi

As a CMCA member Mrs Pisani believed that caravan parks do not suffer where there are RV Parks and dump points and provided other examples.

9.7 Ben Reichsten - Virginia

Mr Reichsten supported the views of the caravan owners and raised his concerns about expenditure in the area from the travellers.

9.8 Janine Innes – Humpty Doo

As the owner of Noonamah Tourist Park Ms Innes strongly opposed to the motion and believed the surrounding commercial caravan parks contribute to the economy by employing staff, use local contractors and supplies. Ms Innes believed there was no benefit to the community giving land to the CMCA as an interstate company and to be run by volunteers.
