# 9.1 Brenton Ascoli – Notice of Motion - Freds Pass Sport & Recreation Reserve Future Planning and Governance

The Interim CEO advised that the Library was transitioned to Council after the 2018/19 Budget was approved and the transactions are the grant money and the expenditure which equal each other out.

# 18. PUBLIC QUESTIONS

# 18.1 Peter Cole – Councillors Input and Freds Pass Sport & Recreation Reserve

Mr Cole questioned if other than Cr Barden and Cr Salter does any of the other Councillors have any input of their constituents in tonight's agenda items.

Mr Cole stated he believed Council has no knowledge of the dynamics of the Freds Pass Reserve and the vast amount of expertise, knowledge, tradesman, access to professionals and resources available. Mr Cole questioned when Council does not have access to these services how they can take over the reserve.

Mayor Bredhauer replied that the motion does not state that the Council intend to 'walk in and take over'. Mayor Bredhauer added that the Council agrees that within the board there is a vast amount of expertise and interest and recognises their wide network. Mayor Bredhauer continued to say that the motion intention is to solidify and build on all those networks, with an aim to make the reserve an even better place. Mayor Bredhauer stated that there was no hidden agenda in the motion.

Mayor Bredhauer disputed Mr Coles question in relation to the Councillors involvement with the Community to make the decisions at Council meetings and vote in a true representation of the people of Litchfield.

# 18.2 Peter Cole – Operations Budget

Mr Cole questioned why there was a zero budget for the Library operations.

The Interim CEO replied, explaining that the decision to transition library services was made by Council after the budget for 2018-19 was set.

Mr Cole commented on the process of the quarterly variations.

Mayor Bredhauer thanked Mr Cole for his statement.

# 18.3 Horst Walter - Draft Municipal Plan & Budget 2019-20 Submissions

Mr Walter questioned the cost to recruit the Chief Executive Officer, requested an explanation on funds for the Developer Contribution Reserve and the Election Reserve, the cost associated to the LG Management Team, the purchase of dvds and the expenditure for Skymesh Satellite. Mr Walter expressed his disappointed that his comments were not included in the submissions for the Draft Municipal Plan 2019-20 Submissions report and requested details on the Fringe Benefit Tax costs.

Mayor Bredhauer advised that the recruitment costs relate to a recruitment company which was a quotation process and the allocation was the upper limit of the recruitment process however the highest tenderer was not selected.

The Interim CEO advised that Developer Contribution Reserve are funds the Council receives from the developers once the development is finalised and Council holds those funds to undertake any work in the subdivisional area if required.

The Interim CEO added that the reserves associated with the Elections are funds set aside for the Elections that are run by the NT Electoral Commission however are a cost to Council.

The Interim CEO advised that LG Management Team was a professional development opportunity for staff.

The Interim CEO informed the meeting that the purchase of dvds related to the review of the collection at the Library and the charges for Skymesh is the NBN connection. The Interim CEO also advised FBT charges relate to the private use of Council's vehicles as part of Senior Staff contracts.

### 18.4 Brenton Ascoli – Local Government Act

Mr Ascoli questioned the casting vote procedure.

Mayor Bredhauer referred Mr Ascoli to the policy which is on the website.

# 18.5 Anthony Dent - Freds Pass Sport & Recreation Reserve

Mr Dent questioned the Mayor as to why she would use her casting vote to go against the current convention instead of voting for the status quo.

Mayor Bredhauer explained that a review of the Freds Pass Reserve was timely and that it is her desire for the reserve to be the best place it could be. Mayor Bredhauer also wants an opportunity to hear the voices of all concerned in order to see that the planning, operations, governance and everything related with the Freds Pass Sports Reserve were exceptional.

Mayor Bredhauer advised the review is about enhancing the reserve which might indicate some new ideas or initiatives, or it may confirm the current convention is working well. Mayor Bredhauer continued to say that the Freds Pass Sport and Recreation Board has a lease until 2025 and it was not the intent of the motion for that to change.

Mayor Bredhauer confirmed that the board would receive a full copy of the report and she understood that the board would be involved in the process, the report is to be developed together and repeated that there was no hidden agenda.

Mayor Bredhauer suggested that it be a collaborative process for the betterment of the reserve into the future for user groups, residents current and future and that this will be the essence of the review.

Mayor Bredhauer agreed to issue a press release reflecting her views and the Council's intentions.
