6.3 Draft 2017/18 Municipal Plan & Budget Including Annual Budget 2017/18

- 1. - 4. Set the date for a Special Council Meeting on 5 July 2017 to adopt the Municipal Plan 2017/2018 including Budget 2017/18.
